The purchase of this Vehicle is on a “**As is where is**” basis with no warranties applicable.

The successful bidder will be responsible for the cost of transferring the ownership.

Persons wishing to view this vehicle must call in advance and must be accompanied by a supervisor prior to entering the Municipal Works Yard. For further information please contact Mr. Merv Reid during normal working hours 7:30 to 4 p.m. at 709-422-1392 to make the necessary arrangements.

All bids **must** be accompanied by the appropriate bid security. The appropriate bid security will be **at least 10%** of the “Amount Quoted” (before HST), payable to the Town of Gander and shall take one of the following forms:

- for bid deposits up and including \$500.00, bid security may be either cheque (uncertified), money order or bank draft; or
- for bid deposits exceeding \$500.00, bid security must be either a certified cheque, money order or bank draft.

Bidders are advised to ensure that their bid deposit is “at least” 10% by multiplying their bid deposit by 10 and making sure that the resulting figure matches or exceeds the amount of their bid (before HST). Any bid deposit received that is not at least 10% of the “Amount Quoted” will render that bid invalid.

Upon closing all bids become irrevocable without forfeiture of the bid security. All bid security will be held until Council has awarded this bid, after which time all unsuccessful bid deposits will be returned.

If this bid is awarded, the successful bidder will have 30 days from notification of award to pay the balance owing on the quoted amount for the item being sold and have the item removed from town property at their own expense. Failure to pay the balance within the 30-day notification period will result in the cancellation of the award and forfeiture of the bid deposit to the Town of Gander. All balances owing must be paid by way of cash, certified cheque, money order, bank draft or debit card.

It is understood by the undersigned that the right is reserved by the Town of Gander to reject any and all bids, and to accept any bid deemed to be in the Town's best interest. The undersigned also agrees that by submission of this Open Call, the bidder agrees to all terms and conditions indicated on this form.

It is also understood by the undersigned that the authorized signature on the proposal hereby affirms that no collusion with other bidders has taken place. Evidence of collusion shall be cause of rejection of the bid.
