4. STANDING COUNCIL BUSINESS

4.1 Regulatory Affairs and Policy

a. Ballfield Clubhouse

Councillor White left Council Chambers at 2:14 p.m. due to conflict of interest.

As part of the 2025 budget, funding was allocated under the Sports Facility Enhancement Program for improvements at the Town's ballfields. The overall project includes four small structures for scorekeeping and storage, completed by Town staff, and a central clubhouse to support events and user groups. A design was developed in consultation with departmental staff.

An RFQ was issued specifically for the envelope portion of the clubhouse, and four local contractors expressed interest. The lowest compliant bid was submitted by Riverstone Construction in the amount of \$125,665.10 (HST inclusive), which was \$9,653.98 below the pre-tender estimate for the specified scope of work. It was noted during discussion that while the bid appears significantly under the overall project budget of \$296,755.32, the broader project includes costs for materials and other items not included in the clubhouse building envelope project.

b. Roundabout

The Town continues to experience steady growth, resulting in increased traffic volumes and safety concerns, particularly at the intersection of Cooper Boulevard and Raynham Avenue/Briggs Street. In response, Englobe Corp. was commissioned to assess the area and recommended the construction of a roundabout to improve safety and traffic flow.

Council has engaged Harborside Transportation Consultants to carry out the detailed design and provide contract administration services for the project. To proceed with the anticipated tender call, the Town will fund the identified shortfall and contingency.

6. **NEW BUSINESS**

6.1 Depot Roof Replacement – RFQ25-14

During a building inspection in 2024, it was identified that a portion of the roof over Maintenance Bays 6, 7, and 8 at the Public Works Depot (34 McCurdy Drive) required recapitalization to prevent water damage to the building envelope. Funding was allocated in the 2025 budget, and a request for quote (RFQ25-14) was issued for the specified work.

Four contractors submitted proposals. The lowest compliant bid was received from R & D Construction Ltd. in the amount of \$140,185.00 HST inclusive, which is \$32,875.37 under the allocated budget.
