All bids **must** be accompanied by the appropriate bid security. The appropriate bid security will be **at least 10%** of the “Amount Quoted” (before HST), payable to the Town of Gander and shall take one of the following forms:

- bid deposits must be either a certified cheque, money order or bank draft made payable to the Town of Gander.

Bidders are advised to ensure that their bid deposit is “at least” 10% by multiplying their bid deposit by 10 and making sure that the resulting figure matches or exceeds the amount of their bid (before HST). Any bid deposit received that is not at least 10% of the “Amount Bid” will render that bid invalid.

Upon closing all bids become irrevocable without forfeiture of the bid security. All bid security will be held until council has awarded this open call for bid, after which time all unsuccessful bid deposits will be returned.

If this open call for bid is awarded, the successful bidder will have 14 days from notification of award to pay the balance owing on the quoted amount for the item being sold and have the item removed from town property at their own expense. Failure to pay the balance within the 14-day notification period will result in cancellation of the award and forfeiture of the bid deposit to the Town of Gander. All balances owing must be paid by way of Cash, certified cheque, money order, bank draft or debit.

It is understood by the undersigned that the right is reserved by the Town of Gander to reject any and all bids, and to accept any bid deemed to be in the Town’s best interest. The undersigned also agrees that by submission of this bid, the bidder agrees to all terms and conditions indicated on this open call for bid form.

It is also understood by the undersigned that the authorized signature on the proposal hereby affirms that no collusion with other bidders has taken place. Evidence of collusion shall be cause of rejection of the bid.
